

Notice to the Public and the Profession

The Time Limits and Other Periods Act (COVID-19)

On July 27, 2020, the federal *Time Limits and Other Periods Act (COVID-19)* (the "Act") came into force. The Act contains provisions that suspend certain time limits established by or under an Act of Parliament and that relate to court proceedings. The Act suspends these time limits from March 13, 2020 to September 13, 2020.

The Act suspends time limits relating to Tax Court of Canada proceedings that are contained in the *Income Tax Act, Excise Tax Act, Tax Court of Canada Act, Tax Court of Canada Rules* (*General Procedure*), *Tax Court of Canada Rules* (*Informal Procedure*), and other statutes and regulations.

Suspension of time

In order to align with the Act, and to provide clarity, consistency and certainty, the Court is issuing a new Order regarding the suspension of time.

The period beginning on March 13, 2020 and ending on September 13, 2020, inclusively, will be excluded from the computation of time under the *Tax Court of Canada Rules (General Procedure)*; all other Rules made under the *Tax Court of Canada Act* governing the conduct of matters that, pursuant to section 12 of the *Tax Court of Canada Act*, are under the Tax Court of Canada's jurisdiction; or an Order or Direction of this Court issued on or prior to March 13, 2020.

The full length of the updated exclusion period is <u>185 days</u>, compared to the previous exclusion period length of 173 days.

Extensions of time to file Notices of Appeal

The Act's effects include the suspension of time limits for filing Notices of Appeal if the time limits fall between March 13, 2020 and September 13, 2020, inclusively. In the Court's Practice Direction and Order dated July 8, 2020, the Court ordered that certain Notices of Appeal filed after the statutory deadline would be treated as including an Application for an extension of time to appeal. The Act's coming into force means that these Notices of Appeal will no longer be considered to be filed after the statutory deadline. As such, the Registry will not be treating these Notices of Appeal as including an Application for an extension of time to appeal. The Registry will serve these Notices of Appeal on the Respondent.

Timetables

The Court will not be issuing Orders for new timetables with adjusted dates. Parties are asked to

adjust the timetable issued by the Court on or before March 13, 2020 in their proceedings by adding 185 days to all dates scheduled in the timetable. This will result in a shift forward of all outstanding steps as of March 13, 2020. Parties can determine their adjusted dates using the chart in Appendix I of this Notice. An example scenario is also contained in Appendix II of this Notice.

If an adjusted timetable is no longer acceptable to the parties, parties may apply to the Court for direction.

Response deadlines to Registry

Correspondence issued by the Registry often requires the parties to provide responses by certain dates. These dates will be extended and updated in the same manner as the suspension of time described above, meaning that the period beginning on March 13, 2020 and ending on September 13, 2020, inclusively, will not be included in the computation of time for the response deadline.

To determine the new response dates, parties should use the chart in Appendix I of this Notice. Neither the Court nor the Registry will be issuing new correspondence with adjusted dates.

If the adjusted date are not acceptable to the parties, parties should contact the Registry.

Appendix I: Adjusted Dates

The chart below displays how dates will be adjusted based on excluding the period beginning on March 13, 2020, and ending on September 13, 2020, inclusively. The full length of the exclusion period is 185 days.

The chart takes into account situations when the adjusted date falls on a Saturday or holiday and also accounts for the statutory excluded period of December 21 to January 7, inclusively.

In order to determine their adjusted timelines, parties should carefully review any orders issued in their proceedings to determine if steps are to be taken on fixed dates or upon the occurrence of an event. Parties should then adjust their dates accordingly.
